Tentative schedule

- 1) **PLEASE** review your entry information and notify us **IMMEDIATELY** of any incorrect division assignment, misspelled names or other mistakes. It's not too late to make your entry complete! There will be a grab-it-and-go express lane and a come-back-with-a-check-or-the-person-who-has-to-sign-something-and/or-have-a-seat-while-we-find-your-paperwork-and-make-copies-or-you-write-a-check fix-it lane at packet pick-up. You can move to the express lane by e-mailing missing information to Deborah at dekalo@comcast.net, faxing Cogginses and copies of USEF cards to Deborah at 615-377-0570 or snail mailing checks and signatures (entry form signatures **MUST** be originals and Trainers **MUST** be at least 18 years old) to Kathy at 1839 London Rd., New Market, TN 37820. **DON'T SNAIL MAIL ANYTHING TO DEBORAH AT THIS POINT!** She will be leaving Middle Tennessee for River Glen early Wednesday and any snail mail might not reach her in time.
- 2) **PLEASE** remember that the Saturday ride times shown on the attachment are **TENTATIVE**. On Friday, the schedule will be adjusted to account for scratches to date. Your **ACTUAL** Saturday ride times will be printed on the back of the XC maps you will find in the Show Office on Friday afternoon.
- 3) **PLEASE** remember that the Sunday ride times on the back of the XC maps will be **TENTATIVE**. The schedule will change as a result of Saturday's no-shows, eliminations, retirements and withdrawals. Your **ACTUAL** Sunday ride times will be posted on the scoreboard on Saturday afternoon: Beginner Novice stadium times by 5 p.m. and Novice, Intermediate, Preliminary and Training XC times by 5:30 p.m.
- 4) **PLEASE** notify Deborah or Kathy *in writing* via e-mail (dekalo@comcast.net or RGlen2000@aol.com) or fax (775-521-1961) if you are scratching. Scratches received in the Show Office by 8 a.m. EASTERN on Friday, November 1st will have their muck deposit check torn up, receive a refund of all USEA/USEF fees and qualify for a possible refund of entry/stabling if we sell out -- we are currently at stall capacity -- and develop a wait list.

(Refunds will be applied to scratches as entries move off any wait list in the order scratches were received.) ***NO SHOW = NO REFUND.***

4) Specific hook-up assignments will be made at the gate upon your arrival, based on the amperage requirements of your trailer or RV. PLEASE FEEL FREE TO CONVEY THAT INFORMATION TO DEBORAH OR KATHY IN ADVANCE!!!

5) We will be running Beginner Novice XC on Saturday afternoon and need fence judges. If you or someone traveling with you can be a fence judge on Saturday afternoon from 3-4 p.m., please let us know.
